Prof. Atta-ur-Rahman obtained his Ph.D. in organic chemistry from Cambridge University (1968). He has 1080 publications to his credit. Prof. Rahman won the prestigious UNESCO Science Prize (1999). He was elected Fellow of the prestigious Royal Society (London) in 2006. He has been conferred honorary doctorate degrees by many universities including Doctor of Science (Sc.D.) by Cambridge University (UK). He was elected Honorary Life Fellow of Kings College, Cambridge University, UK in 2007. He is the President of Network of Academies of Science in Countries of the Organization of Islamic Conference (NASIC). He was the Federal Minister for Science and Technology, Federal Minister of Education and Chairman of the HEC. Prof. Dr. Atta-ur-Rahman is the most decorated scientist of Pakistan with four civil awards: Tamgha-i-Imtiaz, Sitara-i-Imtiaz, Hilal-i-Imtiaz, and Nishan-i-Imtiaz.
